The solution can then be applied to organic or inorganic substrates by brushing, dipping, padding, soaking, spraying or fogging.

**Fogging Application**: This product is for-porous and non-porous room surfaces. All surfaces must be cleaned in accordance with label directions prior to fogging. Fogging is a supplement to normal cleaning procedures and practices.

- 1. Prior to fogging, remove and carefully protect all food products and packaging materials.
- 2. Ensure room is properly ventilated. Wear a dust mist respirator when mixing the use solution and pouring it into the fogging apparatus. Vacate all personnel from the room during fogging and for a minimum of 2 hours after fogging and a minimum of 4 air exchanges (ACH) per hour in the facility. Ensure there is no strong odor which is characteristic of acetic acid, before allowing personnel return to work area.

Using a trigger pump sprayer or pressure sprayer, spray the entire surface area 4"-6" from the surface, making sure the surface is completely covered. Let stand until dry or let stand 3 minutes and wipe dry with cloth or sponge. If spotting occurs, wipe with moist cloth or sponge. Test staining and color-fastness of fabric by treating and drying a small concealed area prior to application.
