

The Biopesticides and Pollution Prevention Division (BPPD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the actions requested fall within the scope of PRN 98-10.

The alternate brand name: WS-90 Technical Grade Gibberellic Acid (GA3) has been added to the product’s records. You must submit one (1) copy of the final printed labeling with the modifications.
