Intended purpose/use:

Isopropyl Alcohol Prep Pads& Isopropyl alcohol wipes-or-Antibacterial wipes can be used to sanitize your household hard, non-porous, non-food contact surfaces. Safe for use on marble, finished wood, glass, ceramics, plastic and stainless steel. This product [Isopropyl Alcohol Prep Pads] is recommended as a sanitizer for use on hard, non-porous, non-food contact surfaces [such as] [Bathroom (toilet seat, door handle), Kitchen (faucets), Office space (monitor, keyboard, mouse, desk top), School, Health club, Gyms, Airports, Grocery stores, Shopping, Centers, Nursery, Daycare centers, Households, Restaurants][and other related hard, non-porous, non-food contact surfaces].

To Dispense Product

For Bucket/Canister:

To Open Package: Open the cap lid and pull up firmly on the lid to remove the entire cap from the bucket. Pullout wipes at an angle toward the central opening in the lid, so that the next wipe pops up automatically, held in place, and does not fall back in. Do not push your finger through the opening. When finished, close the lid securely between uses to retain moisture.

For Individually Wrapped:

To Open Package: Tear open the foil package and unfold the folded pads for use.

For Pouch:

To Open Package: Open the pouch by peeling back the seal. Remove one wipe and reseal the pouch after each use to retain moisture.

To Clean: Use a new wipe on hard, non-porous non-food contact surfaces. Allow to air dry. Repeat for stubborn stains.

To Sanitize: Pre-clean surface by using a new wipe prior to sanitization. Use a new wipe to thoroughly wet hard nonporous non-food contact surface. Allow surface to remain visibly wet for 4 minutes. Use additional wipes to ensure treated surface is continuously wet for 4 minutes. Allow the surface to air dry. Discard wipe after use. DO NOT FLUSH IN TOILET.
