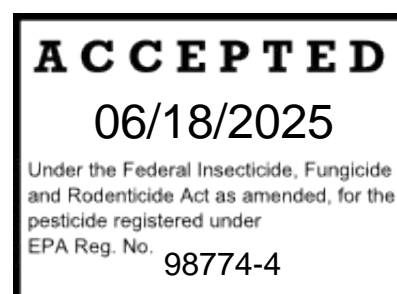

**Intended purpose/use:**

Winner Disinfecting Wipes can be used to disinfect your household hard, non-porous, non-food contact surfaces. Safe for use on sealed marble, finished wood, glass, glazed ceramics, plastic and stainless steel. This product [Winner Disinfecting Wipes] is a disinfectant for use on hard, non-porous, non-food contact surfaces [such as] [Bathroom (toilet seat, door handle, shower areas), Kitchen (faucets, counter, garbage cans), Office space (keyboard, mouse, desk top, pens), Hospital-Not for use on medical devices or medical equipment surfaces, School, Health club, Clinic, Gyms, Airports, Grocery stores, Shopping, Centers, Nursery, Daycare centers, Households, Restaurants]

**To Dispense Product****For Bucket/Canister:**

To Open Package: Open the cap lid and pull up firmly on the lid to remove the entire cap from the bucket. Pullout wipes at an angle toward the central opening in the lid, so that the next wipe pops up automatically, held in place, and does not fall back in. Do not push your finger through the opening. When finished, close the lid securely between uses to retain moisture.

**For Pouch:**

To Open Package: Open the pouch by peeling back the seal. Remove one wipe and reseal the pouch after each use to retain moisture.

To Clean: Use a new wipe on hard, non-porous non-food contact surfaces. Allow to air dry. Repeat for stubborn stains.

To Disinfect: Pre-clean surface by using a new wipe prior to disinfection. Use a new wipe to thoroughly wet hard nonporous non-food contact surface. Allow surface to remain visibly wet for 6 minutes. Use additional wipes to ensure treated surface is continuously wet for 6 minutes. Allow the surface to air dry. Discard wipe after use. DO NOT FLUSH IN TOILET.
