FIRST AID

Fiber Drum with liner: refillable container. Refill this container with sodium carbonate peroxyhydrate only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment or a mix tank. Offer for recycling, if available, or dispose of in a sanitary landfill or by incineration, or if allowed by local and State authorities by burning. If burned, stay out of smoke. If drum is contaminated and cannot be reused, dispose of it in the same manner required for its liner.
