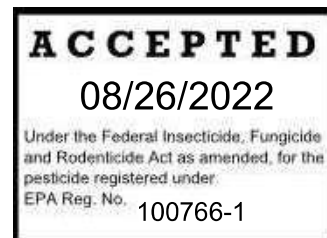

To Clean and Descale Surfaces:

1. If there is visible soil with noticeable encrustations that generally form when the surface has not been descaled in the past 60 days, prepare a solution of 2 parts Dolphin Green® and 1 part water. Otherwise, prepare a solution of 1 part Dolphin Green® and 1 part water.
2. [Apply to] [Spray] [Wipe] [Sponge] [Mop] [Dip] [on] surface until thoroughly wet.

3. Rinse if desired, then drain, wipe, or remove any excess and allow surface to air dry.

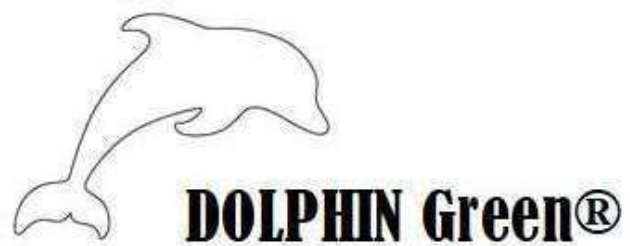

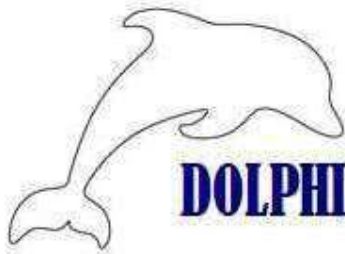
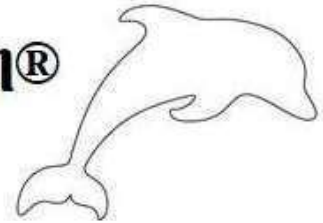
