PRODUCT INFORMATION

Crop Protect Direct Propicon 3.6EC is a broad spectrum fungicide for the control of specified diseases in almonds, bananas, beets (garden), berries, carrots, celery, cereals (wheat, barley, rye, oats, and rice), cilantro, citrus (non-bearing), corn, cranberries, filberts, mint, onions and other bulb vegetables, parsley, peanuts, pecans, pineapple, pistachios, plantains, sorghum, stone fruit (apricots, nectarines, peaches, plums, and prunes), sugarbeets, sugarcane, tree nuts, turf grown for seed, and turfgrass and ornamentals.

Precaution: Failure to follow directions and precautions on this label may result in crop injury, poor disease control, or illegal residues.

Restriction: DO NOT use this product in greenhouses or as a tree injection.

Rotational Crops

To avoid possible illegal residues, **DO NOT** plant any other crop intended for food, grazing, or any component of animal feed or bedding within 105 days of an application of **Crop Protect Direct Propicon 3.6EC** to the preceding crop unless the second crop appears on this label. Alfalfa can be planted 75 days after the last application of **Crop Protect Direct Propicon 3.6EC** if the total application of propiconazole has not exceeded 0.22 pound active ingredient per acre during the previous year.

Integrated Pest Management

Integrate **Crop Protect Direct Propicon 3.6EC** into an overall disease and pest management (IPM) strategy whenever the use of fungicide is required. Follow cultural practices known to reduce disease development. Consult your local agricultural authorities for additional IPM strategies established for your area. **Crop Protect Direct Propicon 3.6EC** may be used in state agricultural extension advisory (disease forecasting) programs using the directed application timing based upon environmental factors favorable for disease development.

Resistance Management

For resistance management, **Crop Protect Direct Propicon 3.6EC** contains a Group 3 fungicide. Any fungal population may contain individuals naturally resistant to **Crop Protect Direct Propicon 3.6EC** and other Group 3 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Follow appropriate resistance management strategies.

To delay fungicide resistance, take one or more of the following steps:

- Rotate the use of **Crop Protect Direct Propicon 3.6EC** or other Group 3 fungicides within a growing season sequence with different groups that control the same pathogens.
- Use tank mixtures with fungicide from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses historical
 information related to pesticide use, and crop rotation, and which considers host plant resistance, impact
 of environmental conditions on disease development, disease thresholds, as well as cultural, biological and
 other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications. Note that using predictive models alone is not sufficient to manage resistance.
- Monitor treated fungal populations for resistance development.
- Contact your local extension specialist or certified crop advisor for any additional pesticide resistancemanagementand/or IPM guidelines for specific crops and pathogens.

Prepare no more spray mixture than is required for the immediate operation. Thoroughly clean spray equipment before using this product. Agitate the spray solution before and during application. Rinse spray tank thoroughly with clean water after each day's use and dispose of pesticide rinsate by application to an already treated area.

Crop Protect Direct Propicon 3.6EC – Alone: Add 1/2 - 2/3 of the required amount of water to the spray or mixing tank. With the agitator running, add the **Crop Protect Direct Propicon 3.6EC** to the tank. Continue agitation while adding the remainder of the water. Begin application of the spray solution after the **Crop Protect Direct Propicon 3.6EC** has completely dispersed into the mix water. Maintain agitation until all of the mixture has been sprayed.

Crop Protect Direct Propicon 3.6EC – Tank Mixtures: Crop Protect Direct Propicon 3.6EC is usually compatible with all tank mix partners listed on this label. To determine the physical compatibility of Crop Protect Direct Propicon 3.6EC with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to 1 qt. of water. Add wettable powders and water-dispersible granular products first, then liquid flowables, and emulsifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

Add 1/2-2/3 of the required amount of water to the spray or mixing tank. With the agitator running, add the tank mix partner into the tank. Allow the material to completely dissolve and disperse into the mix water. Continue agitation while adding the remainder of the water and **Crop Protect Direct Propicon 3.6EC** to the spray tank. Allow the **Crop Protect Direct Propicon 3.6EC** to completely disperse. Spray the mixture with the agitator running.

DO NOT apply this product in a mix with a dodine fungicide for any uses on this label (except almonds), or crop injury will occur.

If using **Crop Protect Direct Propicon 3.6EC** in a tank mix, it is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture. **DO NOT** tank mix this product with any product that prohibits such mixing. Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are registered.

APPLICATIONS INSTRUCTIONS

Crop Protect Direct Propicon 3.6EC is most effective when applied and allowed to dry before a rainfall. Avoid applying **Crop Protect Direct Propicon 3.6EC** under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur. **DO NOT** apply in a manner which results in exposure to humans or animals.

Ground Application: For tree crops, apply **Crop Protect Direct Propicon 3.6EC** in a minimum of 50 gals. of water per acre unless otherwise specified. For all other crops, apply **Crop Protect Direct Propicon 3.6EC** in a minimum of 10 gals. of water per acre unless otherwise specified.

Aerial Application: For tree crops, apply **Crop Protect Direct Propicon 3.6EC** in a minimum of 10 gals. of water per acre unless otherwise specified. For all other crops, apply **Crop Protect Direct Propicon 3.6EC** in a minimum of 2 gallons of water per acre unless otherwise specified.

Chemigation Application: Apply Crop Protect Direct Propicon 3.6EC through properly equipped chemigation systems for disease control in the labeled crops. Refer to crop specific use directions for application rates, timing and frequency of application. DO NOT apply Crop Protect Direct Propicon 3.6EC by chemigation to other labeled crops except as specified in JABCO, LLC supplemental labeling or product bulletins. When applying this product by chemigation, DO NOT exceed labeled rates or apply more frequently than directed for conventional application methods. Crop Protect Direct Propicon 3.6EC, alone or in combination with other pesticides that are registered for application through irrigation systems, may be applied through irrigation systems. For chemigation application to labeled crops, apply in 0.1 to 0.25 inches of water unless otherwise specified. Chemigation with excessive water may leadto a decrease in efficacy.

MANDATORY SPRAY DRIFT MANAGEMENT

Aerial Applications:

- **DO NOT** release spray at a height greater than 10 ft above the ground or vegetative canopy, unless a greater application height is necessary for pilot safety.
- Applicators must select nozzle and pressure that deliver medium or courser droplets in accordance with American Society of Agricultural & Biological Engineers Standard 641 (ASABE S64I for aerial applications).

- **DO NOT** apply when wind speeds exceed 15 mph at the application site. If the windspeed is greater than 10 mph, the boom length must be 65% or less of the wingspan for fixed wing aircraft and 75% or less of the rotor diameter for helicopters. Otherwise, the boom length must be 75% or less of the wingspan for fixed-wing aircraft and 90% or less of the rotor diameter for helicopters.
- **DO NOT** apply during temperature inversions.

Ground Boom Applications:

- **DO NOT** release spray at a height greater than 4 feet above the ground or crop canopy.
- Applicators must select nozzle and pressure that deliver medium or courser droplets in accordance with American Society of Agricultural & Biological Engineers Standard 572 (ASABE S572).
- **DO NOT** apply when wind speeds exceed 15 mph at the application site.
- **DO NOT** apply during temperature inversions.

Boomless Ground Applications:

- Applicators must select nozzle and pressure that deliver medium or courser droplets in accordance with American Society of Agricultural & Biological Engineers Standard 572 (ASABE S572).
- **DO NOT** apply when wind speeds exceed 15 miles per hour at the application site.
- **DO NOT** apply during temperature inversions.

SPRAY DRIFT ADVISORIES

THE APPLICATOR IS RESPONSIBLE FOR AVOIDING OFF-SITE SPRAY DRIFT. BE AWARE OF NEARBY NON-TARGET SITES AND ENVIRONMENTAL CONDITIONS.

IMPORTANCE OF DROPLET SIZE

An effective way to reduce spray drift is to apply large droplets. Use the largest droplets that provide target pest control. While applying larger droplets will reduce spray drift, the potential for drift will be greater if applications are made improperly or under unfavorable environmental conditions.

Controlling Droplet Size - Ground Boom

- **Volume** Increasing the spray volume so that larger droplets are produced will reduce spray drift. Use the highest practical spray volume for the application. If a greater spray volume is needed, consider using a nozzle with a higher flow rate.
- **Pressure** Use the lowest spray pressure recommended for the nozzle to produce the target spray volume and droplet size.
- **Spray Nozzle** Use a spray nozzle that is designed for the intended application. Consider using nozzles designed to reduce drift.

Controlling Droplet Size - Aircraft

• **Adjust Nozzles** - Follow nozzle manufacturers' recommendations for setting up nozzles. To reduce fine droplets, nozzles should be oriented parallel with the airflow in flight.

BOOM HEIGHT - Ground Boom

For ground equipment, the boom should remain level with the crop and have minimal bounce.

RELEASE HEIGHT - Aircraft

Higher release heights increase the potential for spray drift.

SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce spray drift. Consider using shielded sprayers. Verify that the shields are not interfering with the uniform deposition of the spray on the target area.

TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

TEMPERATURE INVERSIONS

Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

WIND

Drift potential generally increases with wind speed. AVOID APPLICATIONS DURING GUSTY WIND CONDITIONS. Applicators need to be familiar with local wind patterns and terrain that could affect spray drift.

SPRAY DRIFT ADVISORIES

Boomless Ground Applications:

Setting nozzles at the lowest effective height will help to reduce the potential for spray drift.

Handheld Technology Applications:

• Take precautions to minimize spray drift.

SPRAY EQUIPMENT

Thorough coverage is necessary to provide good disease control. Avoid spray overlap as crop injury may occur.

Air-assisted or air-blast sprayers use a forced air stream to move spray droplets into the canopy. Set up the fan to deliver only enough air volume to penetrate the canopy and provide good coverage. Adjust deflectors or other aiming devices to direct spray only to the target area.

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate sprayer before use.

Use a pump with sufficient capacity to maintain 35-40 psi at nozzles and provide sufficient agitation in tank to keep mixture in suspension (this requires recirculation of 10% of tank volume per minute). Use a jet agitator, or liquid sparger tube for agitation. **DO NOT** use air sparging.

Although **Crop Protect Direct Propicon 3.6EC** is an emulsifiable concentrate, it is suggested that screens be used to protect the pump and to prevent nozzles from clogging. Screens placed on suction side of pump must be 16-mesh or coarser. **DO NOT** place a screenin the recirculation line. Use 50-mesh or coarser screens between the pump and boom, and where required, at the nozzles. Check nozzle manufacturer's directions.

For more information on spray equipment and calibration, consult sprayer manufacturers' and state directions. For specific local directions and spray schedules, consult the current state agricultural experiment station guidelines.

CHEMIGATION INSTRUCTIONS

Precautions:

- Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. DO NOT
 apply this product through any other type of irrigation system.
- Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.
- If you have questions about calibration, contact State Extension Service specialists, equipment manufacturers, or other experts.
- **DO NOT** connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.
- A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments if the need arises
- Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone
 (RPZ), backflow preventer or the functional equivalent in the water supply line upstream from the point of
 pesticide introduction. As an option to the RPZ, discharge the water from the public water system into a
 reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the
 flow outlet end of the fill pipe and the top or overflow rim of the reservoir tank or at least twice the inside
 diameter of the fill pipe.

Application Instruction: DO NOT inject **Crop Protect Direct Propicon 3.6EC** at full strength or deterioration of valves and seals may occur. Use a dilution ratio at least 10 parts water to 1 part **Crop Protect Direct Propicon 3.6EC**. **Crop Protect Direct Propicon 3.6EC** is corrosive to many seal materials. Leather seals are best. EPDM or silicone rubber seals can be used but must be replaced once a year. **DO NOT** use Viton, Buna- N, Neoprene, or PVC seals.

Specific Equipment Requirements

- The system must contain a functional check-valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water-source contamination from backflow.
- The pesticide injection pipeline must contain a functional, automatic, quick-closing check-valve to prevent the flow of fluid back toward the injection pump.
- The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawnfrom the supply tank when the irrigation system is either automatically or manually shut down.
- The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- The irrigation line or water pump must include a functional pressure switch that will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- Systems must use a metering pump, including a positive displacement injection pump (e.g., diaphragm pump), effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- **DO NOT** apply when wind speed favors drift beyond the area intended for treatment.

Center Pivot Irrigation Equipment

- Use only with drive systems which provide uniform water distribution.
- **DO NOT** use end guns when applying **Crop Protect Direct Propicon 3.6EC** through center pivot systems because of non-uniform application.

- Make sure the system is fully charged with water before starting injection of the Crop Protect Direct Propicon
 3.6EC solution. Time the injection to last at least as long as it takes to bring the system to full pressure.
- Maintain constant solution tank agitation during the injection period.
- Stop injection equipment after treatment is completed. Continue to operate the system until the **Crop Protect Direct Propicon 3.6EC** solution has cleared the sprinkler head.

Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

- Maintain constant solution tank agitation during the injection period.
- Operate the system at normal pressures specified by the manufacturer of the injection equipment and used for the time interval established during the calibration.
- Inject **Crop Protect Direct Propicon 3.6EC** at the end of the irrigation cycle or as a separate application to maximize foliar fungicide retention.

MIXING INSTRUCTIONS

Tank mixing instructions: It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

Fill the spray tank 1/2 - 3/4 full with water. Add the proper amount of **Crop Protect Direct Propicon 3.6EC** and then add the rest of the water. Provide sufficient agitation during mixing and application to maintain a uniform emulsion.

If Crop Protect Direct Propicon 3.6EC is tank mixed with other products, use the following sequence:

- 1. Always check the compatibility of the tank mix using a jar test with proportionate amounts of **Crop Protect Direct Propicon 3.6EC**, other chemicals to be used, and the water, before mixing in the spray tank.
- 2. Provide sufficient jet or mechanical agitation during filling and application to keep the tank mix uniformly suspended.
- 3. Fill tank at least 1/2 full of clean water.
- 4. Add wettable powders to the tank first, allowing them to completely suspend in the tank before proceeding. This process can be hastened by premixing the product in water before adding to the tank.
- 5. Add flowables or suspensions next.
- 6. Add Crop Protect Direct Propicon 3.6EC next.
- 7. Add emulsifiable concentrates last.
- 8. **DO NOT** leave tank mix combinations in the spray tank for prolonged periods without agitation. Mix and apply them the same day.

Tank Mixes

For broader spectrum control, **Crop Protect Direct Propicon 3.6EC** can be tank mixed with other fungicides. For example, a metalaxyl-m product may be tank mixed with **Crop Protect Direct Propicon 3.6EC** or used alone when conditions are favorable for Pythium blight. **Crop Protect Direct Propicon 3.6EC** is also compatible with numerous herbicides and insecticides. Check compatibility before tank mixing. Add a thifensulfuron product to tank mixes which are incompatible. Follow the directions under **Mixing Instructions** for tank mixes. Observe all directions, precautions, and limitations on labeling of all products used in tank mixes. Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are registered.

Turfgrass and Dichondra Disease Control

- Apply in sufficient water to ensure thorough coverage.
- Apply after mowing OR allow sprayed area to dry completely before mowing.

Establishment of Cool Season Turfgrass

Crop Protect Direct Propicon 3.6EC controls many turfgrass diseases; its primary use is as a fungicide for use against the diseases listed on this label. As an additional benefit, **Crop Protect Direct Propicon 3.6EC** improves the rate of establishment when it is applied to cool season grassseedlings or sod.

New Seedlings: Apply 0.35 fl. oz. (0.0098 lb. ai) per 1000 sq. ft. at the 2- to 3-leaf stage of growth for faster root development and top growth.

Sod: Apply 0.35 fl. oz. (0.0098 lb. ai) per 1000 sq. ft. 2 to 6 weeks before cutting for increased sod knitting and faster establishment after laying.

Ornamental Plants (Nurseries [Field] and Landscape Plantings)

Use **Crop Protect Direct Propicon 3.6EC** in a preventative disease control program. To determine the use directions for controlling a disease on an ornamental plant species, select the plant species in Table 1. The number(s) in parentheses following the listed plant species refers to the disease(s) controlled in Table 2. Find the disease in Table 2. The letter in brackets following the disease refers to the application regime in Table 3.

Allow spray to dry before applying overhead irrigation.

The optimal benefit of **Crop Protect Direct Propicon 3.6EC** is obtained when used in conjunction with sound disease management practices.

Ornamental Use Directions

Crop Protect Direct Propicon 3.6EC may be used at rates of 0.75 to 8.7 fluid ounces (0.021 – 0.244 lb. ai) per 100 gallons of water for disease control in ornamentals (see Tables 1, 2 and 3).

For best control, begin **Crop Protect Direct Propicon 3.6EC** applications before disease development.

For disease control in landscapes, apply 2.2 to 3.0 fluid ounces (0.062 – 0.084 lb. ai) per 100 gallons water every 21 days. For outdoor uses, you can apply up to 2.0 gallons (7.2 lbs. ai) of **Crop Protect Direct Propicon 3.6EC** per acre per crop per year.

Ornamental Use Precautions

Plant tolerances to **Crop Protect Direct Propicon 3.6EC** have been found acceptable for the specific genera and species of plants listed under the **Directions for Use**.

- [A] Mix 0.75 to 1.5 fluid ounces (0.021 0.042 lb. ai) of **Crop Protect Direct Propicon 3.6EC** in 100 gallons of water and apply as a full coverage spray to the point of drip. Reapply every 14 to 21 days during the period of primary infection. If disease is present, tank mix with an EPA-registered contact fungicide. For flower blight, apply **Crop Protect Direct Propicon 3.6EC** when there is 5 to 10% bloom and again at 70 to 100% bloom. For dogwoods, apply the 0.75 to 1.5 fluid ounces (0.021 0.042 lb. ai) rate every 14 days, or apply 3.0 fluid ounces (0.084 lb. ai) of **Crop Protect Direct Propicon 3.6EC** every 28 days.
- [B] Mix 1.8 to 3.0 fluid ounces (0.051 0.084 lb. ai) of **Crop Protect Direct Propicon 3.6EC** in 100 gallons of water and apply as a full coverage spray to the point of drip. Apply as needed, beginning when conditions favor disease development. For blackspot, apply in tank mix with a registered contact fungicide labeled for blackspot. For calendula, apply every 30 days. For diplodia tip blight, make a total of 3 applications every 14 days prior to the major period of infection. For juniper phomopsis blight, make an initial applicationas soon as junipers start to grow and reapply every 14 to 21 days during the period of active growth.
- [C] Mix 3.0 to 4.5 fluid ounces (0.084 0.127 lb. ai) of **Crop Protect Direct Propicon 3.6EC** in 100 gallons of water and apply as a full coverage spray to the point of drip. Apply every 30 days, beginning when conditions favor disease development. For pecans, apply the 12.0 fluid ounces (0.34 lb. ai) rate. Beginning at bud break, make a total of 3 applications 14 days apart. For walnuts, apply 3.0 fluid ounces every 14 to 21days. For ray blight, apply 4.5 fluid ounces (0.127 lb. ai) every 7 days or 7.5 fluid ounces (0.211 lb. ai) every 14 days. For impatiens, bayberry, linden, magnolia, sweetgum and wax myrtle, the maximum use rate is 8.0 fluid ounces (0.224 lb. ai).
- [D] Mix 6.0 fluid ounces (0.168 lb. ai) of **Crop Protect Direct Propicon 3.6EC** in 100 gallons of water and apply as a full coverage spray to the point of drip. Apply every 14 to 28 days beginning when conditions favor disease development. For douglas fir needle rust, apply once in May. For tip blight, make an initial application in mid- to late winter, and 3 additional applications at 2-month intervals.
- [E] Mix 7.5 to 8.7 fluid ounces (0.211 0.244 lb. ai) of **Crop Protect Direct Propicon 3.6EC** in 100 gallons of water and apply as a full coverage spray to the point of drip. Apply within the June to August time period.
