The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



(1) alfalfa grown for seed; legume vegetable (Crop Group 6); vegetable, root, except sugarbeet and carrot (Subgroup 1B); Vegetable, tuberous and corn (Subgroup 1C); buffalograss; vegetable, brassica, head and stem, (Crop Group 5-16);;; Carrot; cilantro; corn(field, sweet or pop); coriander; cotton; cottonseed (Crop Subgroup 20C); cucurbit vegetable (Crop Group 9);dill; fruiting vegetable (Group 8-10, except tabasco peppers); established grasses grown for seed; guymon bermudagrass for seed production; lettuce (head and leaf); brassica leafy greens (Crop subgroup 4-16B); caneberry (Subgroup 13-07A); bushberry (Subgroup 13-07B); low-growing berries (Subgroup 13-07G excluding cranberry); kohlrabi; meadowfoam grown for seed, nurseries, turf, and landscape plantings; onion (bulb) (Crop Subgroup 3-07A); onion (green) (Crop Subgroup 3-07B) peanuts;; peaches; radishes grown for seed (excluding daikon); rosemary; safflowers; sesame; sorghum (sweet, grain or forage); soybeans; soybean, immature seed; spinach; stevia; sugar beet; sugarcane; sunflower

(Subgroup 20B); Swiss chard; stalk and stem vegetable, except kohlrabi (Subgroup 22A); Leaf petiole vegetable (Subgroup 22B)
