## Directions for Use

Remove the Octenol Cartridge from the sealed pouch and peel the protective cover from the face of the cartridge. Avoid touching the openings in the cartridge and always wash hands thoroughly after contact.

## Installation

Refer to the owner's manual accompanying your Flowtron ~~or Galaxie insect control~~ device for instructions on locating and installing the octenol cartridge.

~~For other brands of insect control devices, use the enclosed double face tape to secure the cartridge in the location specified by the device's owner manual.~~

When your device is operating, it will produce the required heat and convective air flow to vaporize the attractant and disperse it at the proper rate per hour. For best results, replace cartridge after 450 hours of use.

## Storage and Disposal

Storage: Store unopened mosquito attractant cartridge in a cool, dry place until ready to use.

Disposal: Non-refillable container. Do not reuse or refill this cartridge. If empty – Place in trash or offer for recycling if available. If partly filled – Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused products down any indoor or outdoor drain.
