Remove all lower drawers in kitchen and bathroom cabinets, bedroom drawers and chests of drawers, the scatter liberally in drawer wells.

Directions for Applying in New Construction to Control Cockroaches. When treating large areas, such as well voids, soffit and subcabinet voids in new existing construction, dust liberally using dusting application equipment.

Directions for Applying as a Mop Solution to Control Cockroaches. Add 1 cup of powder to each gallon of rinse water. Apply to floor areas only. Make only enough for each application. Supplemental treatment only.
