This letter acknowledges receipt of an amendment for the above-listed Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. The SLN registration permits use of Medallion WDG (fludioxonil) on greenhouse grown peonies to control Botrytis cinerea. This amended SLN will extend the expiration date from 12/31/23 to 12/31/28. Everything else remains the same.

Following immersion of the buds and stem in the application mixture, gently shake stems to reduce excess liquid. Allow stems and buds to dry prior to packing for storage or shipping.
