For Air - Use 12.5 fluid ounce of product in at least 75 gallons of water per acre.

Dilution Rate: See “Dosage” above.

Method of Application: Ground and Air

Frequency/Timing of Application:

Only one application per year. Apply at cauliflower stage of inflorescence development. Product is most effective when used On-crop years but may not be effective on Off-Crop years.

Restricted-Entry Interval (REI): 4 HOURS

Preharvest Interval (PHI): 0 DAYS

Other Requirements:

- None

Specific Use Restrictions:

- Do not apply through any type of irrigation systems.


