This letter acknowledges receipt of an amendment for the above-listed Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. The original SLN registration permits use of Onager Miticide (hexythiazox) for mite control on grass grown for seed in Colorado. This amendment will extend the expiration date to December 31, 2026 for use of products containing Onager Miticide. All other aspects remain the same.

The Agency has completed a review of the amendment of this use and acknowledges the State's Special Local Need registration, as amended. Applications made by air to dense foliage may not provide adequate coverage of lower leaf surfaces for sufficient control. Use of higher labeled rates may be necessary. Chemigation: This product may be applied through irrigation systems*. Refer to the EPA registered label for chemigation directions.
	 Do not cut current year's treated seed crop for hay or forage. Do not graze or feed livestock on cover crops growing in treated areas. Screenings from seed processing are prohibited from food or feed channels. All Onager treated seed screenings must be removed from the food or feed market. Treated seed is not to be used for sprouting. All seed treated with Onager is to be tagged at processing plants "NOT FOR HUMAN OR ANIMALCONSUMPTION". It shall be the grower's responsibility to notify the processing plants of any seed crop treated with Onager. Do not apply more than a total of 24 oz. formulated product per acre per year. Do not make more than one application per year. 		

- Onager is an emulsifiable concentrate to be diluted with water for application in commercial plantings only.
- Apply Onager prior to adult mite build up. Onager will not control adult spider mites. Use higher rates on moderate to high
 mite infestations or for larger plants with a dense canopy. If adult mites are present in medium to high populations, better
 results may be obtained using Onager in combination with a registered contact adulticide. The use of less than label rates
 is not recommended with Onager.
- Do not make more than one application of Onager or any other Hexythiazox product to the same crop per year.
- Do not plant rotational crops other than those on the Section 3 label within 120 days of this application.
