This letter acknowledges receipt for the above-listed Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. This SLN registration permits use of a new formulation, Gramoxone SL 3.0 (paraquat dichloride) as a harvest aid on alfalfa grown for seed in Colorado to replace Gramoxone SL 2.0 that expires July 1, 2022. Leading to a need for this SLN registration. All other aspects of the label remain the same.

The Agency has completed a review of this use and acknowledges the State's Special Local Need registration. Please inform the registrant that we have placed a copy of the SLN label in our files. Always Add One of the Following

Add a nonionic surfactant containing 80% or more surface-active agent at 0.25% v/v (2 pint per 100 gallons) of the finished spray volume for ground applications. For aerial applications, add a nonionic surfactant at 0.25% v/v (2 pints per 100 gallons) of the finished spray volume.

Precautions, Restrictions, and Comments

- DO NOT apply more than 2 applications per year.
- DO NOT exceed 1.0 lb ai/A/year of paraquat containing products for all combined uses
- DO NOT harvest until at least 4 days after application.
- DO NOT apply when weather conditions favor drift from treated areas.
- DO NOT apply by ground equipment within 25 ft or by air within 75 ft of lakes; reservoirs; rivers; permanent streams, marshes or natural ponds; estuaries; and commercial fish ponds.
- For use only on fields in production of alfalfa seed.
- Not for use on fields producing alfalfa for livestock feed.
- DO NOT graze current year's treated alfalfa seed crop.
- DO NOT cut current year's treated alfalfa seed crop for hay or forage.
- Treated alfalfa seed is not to be used for sprouting. All alfalfa seed treated with Gramoxone SL 3.0 is to be tagged at conditioning plant, "NOT FOR HUMAN CONSUMPTION OR ANIMAL CONSUMPTION". It shall be the grower's responsibility to notify the conditioning plant of any seed crop treated with Gramoxone® SL 3.0.
- Screens and seed from seed conditioning are prohibited from feed channels. All Gramoxone SL 3.0 treated alfalfa seed screenings must be removed from the feed market.
- DO NOT apply this product through any type of irrigation system.
