Restrictions:

- Quilt Xcel Fungicide may be applied **either** as an In-Furrow Application, **or** a Conveyer Belt Treatment.
- Regardless of which application method used, **DO NOT** apply more than 21 fl oz/A of Quilt Xcel Fungicide at planting.

In-Furrow Application

Apply Quilt Xcel Fungicide to sugarcane seed pieces as an in-furrow spray at planting at the rate of 1.4 – 3.0 fl oz per 1000 row feet using sufficient water to ensure coverage. Mount the spray nozzle so the spray is directed into the furrow just before the seed cane is covered. Use

the higher rate when the weather conditions are expected to be conducive for disease development.

Conveyer Belt Treatment (Attached to Planting Equipment)

Treat seed pieces with Quilt Xcel Fungicide spray solution at the rate of 1.4 – 3.0 fl oz per 1000 row feet, using in-line directed spray sufficient to wet cut ends.
