This letter acknowledges receipt of the above-listed Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. The SLN registration permits use of Movento MPC (containing spirotetramat) in citrus during bloom to control the Asian citrus psyllid (ACP). You indicated that some citrus has been observed to present varying level of bloom year-round, when there is an urgent need to control the ACP (vector of citrus greening disease, also known as Huanglongbing (HLB)), and that such use will present minimal risk to pollinators; thus, there is a need for this use.

The Agency has completed a review of this use and acknowledges the State's SLN registration. Please inform the registrant that we have placed a copy of the SLN label in our files.
