DIRECTIONS FOR USE

SPLAT VERB is a ready-to-use, thick liquid formulation. Check product 24 hours before using. If the product has been stored in a refrigerated area and has hardened, allow at least 48 hours at room temperature to achieve a workable consistency.

MODE OF ACTION: SPLAT VERB repels using synthetic anti-aggregation pheromone applied as dollops to the tree.

APPLICATION RATE: For single tree protection, the recommended application rate is 2.6 to 4.0 oz (75 to 115 g) of SPLAT VERB per tree. For area protection, the recommended application rate is 1.6 to 11.0 lb (750 g to 5 Kg) of SPLAT VERB per acre. Do not exceed 22.0 lb (10 Kg) of SPLAT VERB per acre per year. For coffee and macadamia, DO NOT exceed 150 g A.I. per acre per year. Consult a qualified pest control advisor or ISCA Technologies for the recommended rate of application, as it will vary depending on the pest population and field conditions.

APPLICATION METHOD: SPLAT VERB should NOT be diluted prior to use. SPLAT VERB can be applied manually through hand-held caulking gun-style dosing guns, or mechanically using pressurized backpack sprayers or similar systems loaded onto tractors, all-terrain vehicles, planes, or similar equipment. Always consult a qualified pest control advisor or ISCA Technologies to ensure optimum application of product is achieved.

PLACEMENT: SPLAT VERB functions best when applied directly to the tree bole or trunk at a height of 2 m (6.6 ft) from the ground. For alternative placement, consult a qualified pest control advisor or ISCA Technologies.

USE RESTRICTIONS: Do not apply this product through any type of irrigation system. Do not apply SPLAT VERB when the ambient temperature is below 55 °F (13 °C) or above 95 °F (35 °C). Do not apply if rain is expected within 4 to 6 hours of application.

0	Coffee (<i>Coffea arabica</i>)	Beetles include : <i>Hypothenemus hampei</i>	Do not apply more than 150 grams of active ingredient (3.3 lb or 1.5 Kg of SPLAT VERB) per acre per year. Reapply as needed.
