#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Follow all applicable directions, restrictions and precautions on the EPA-registered label. This labeling must be in the possession of the user at the time of pesticide application.

PLANT	PESTS CONTROLLED	AMOUNT OF ORTHENE TURF, TREE & ORNAMENTAL SPRAY 97 PER 100 GAL.	APPLICATION INSTRUCTIONS
Gladiolus Corms	Thrips	1 lb (16 oz)	Apply the specified amount of ORTHENE TURF, TREE & ORNAMENTAL 97 SPRAY in 100 gallons of water. Dip corms in the ORTHENE TURF, TREE & ORNAMENTAL 97 SPRAY solution for 15 minutes. Do not dip corms for more than 15 minutes.

#### **RESTRICTIONS:**

- Handling of treated corms from treatment to planting is permitted only with use of a fork truck, crane or other mechanical means, in order to prevent handler direct contact with the treated corms.
- Do not apply ORTHENE TURF, TREE & ORNAMENTAL 97 SPRAY as a dip more than once every 28 days.
- Do not apply through any type of irrigation system.

#### PRECAUTIONS:

- Apply ORTHENE TURF, TREE & ORNAMENTAL 97 SPRAY only to healthy corms.
- Test a limited number of each variety prior to an operational application, in order to ensure all varieties are tolerant to ORTHENE TURF, TREE & ORNAMENTAL 97 SPRAY.

#### PERSONAL PROTECTIVE EQUIPMENT (PPE):

- The following PPE must be worn during the mixing, loading and handling process:
  - o Chemical resistant gloves such as Butyl rubber, Nitrile rubber, or Neoprene which are at least 14 mils thick.
  - Long-sleeved shirt and long pants
  - Socks and Shoes
