Dear Dr. Zhang:

This letter acknowledges receipt of the amendment to the above-listed Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. The SLN registration permits use of the product Rozol® Vole Bait (chlorophacinone) on fallow agricultural land, rangeland, and crop borders/buffers to control Townsend's ground squirrels which cause significant damage to land, equipment, and crop yield losses. The SLN notification indicates that there remains a need for this use, as the only alternative section 3 zinc phosphide baits do not provide satisfactory control. The amendment extends the expiration date to December 31, 2028, but all other directions for use remain unchanged.

The Agency has completed a review of this use and acknowledges the amendment to the State's Special Local Need registration. #### DIRECTIONS FOR USE

**Spot baiting:** Scatter ¼ cup of bait (approximately 2 ounces) around burrows and active runways. Do not pile the bait. Make a second application 5 to 7 days after the first, following the same procedure as the first application. If squirrel activity persists, a third application may be made 5 to 7 days later. Do not exceed 10 pounds of bait per acre per application. Do not exceed 30 pounds of bait per acre per year.

**Bait station baiting:** Apply bait in secured tamper-resistant bait stations. Fill bait stations with 1 to 4 pounds of bait, and secure the stations near active burrows, runways, and other locations where signs of ground squirrel activity are observed. Space stations 20 to 100 feet apart, depending on the density of the squirrel population. Check stations at least weekly to ensure an uninterrupted supply of fresh bait for at least 30 days or until all signs of squirrel feeding have stopped. Do not exceed 4 pounds of bait per station.

**Surveillance and Follow-Up:** Collect and dispose of dead ground squirrels and search for non-target animals 4 days after the first application and at subsequent intervals of 1 to 2 days for at least 2 weeks after the last bait application, or longer if carcasses are still being found. Wearing gloves, collect and properly dispose of visible carcasses of ground squirrels and other species found in or near treated areas. Dead animals buried on site must be buried a minimum of 18 inches below the ground surface, preferably deeper. Wear gloves and use leakproof plastic bags or other suitable containers for transporting carcasses not buried on site.

#### RESTRICTIONS / PRECAUTIONS:

- Apply this product when ground squirrels are active, approximately mid-February to mid-July.
- Do not apply this product directly to water or within 10 feet of surface water (i.e. streams, rivers, lakes).
- Do not broadcast bait. Do not apply this product by any method not specified on this label.
- Keep away from humans, domestic animals and pets during application, handling and storage.
- This product is extremely toxic to mammals and birds. This SLN label should not be used where impact on listed threatened or endangered species is likely. Consult the Federal label for additional restrictions and precautions to protect fish and wildlife.
