This letter acknowledges receipt of an amendment for the above-listed Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. The original SLN registration permits use of Gowan Malathion 8F Insecticide (malathion) on caneberries (blackberries, boysenberries, dewberries, loganberries, and raspberries) to control Spotted Wing Drosophila. This amendment updates the label formatting, allows 4 applications per year of up to 2 pints of product per acre per application, with a minimum retreatment interval of 7 days, and extends the expiration date to 12/31/2027.

The Agency has completed a review of the amendment for this use and acknowledges the State's SLN registration, as amended.
