This letter acknowledges receipt of the above Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. This SLN registration permits use of *Bacillus thuringiensis* subsp. *kurstaki* strain ABTS-351 fermentation solids, spores, and insecticidal toxins on trees and other vegetation near water to control Asian gypsy moth and light brown apple moth. You indicated currently registered products were unclear with regard to treatment for Asian gypsy moth and light brown apple moth on trees and other vegetation near water, thereby necessitating this SLN registration.



Applications should be done such that deposition into adjacent water is minimized.
