

This amendment will remove “®” from the product name and extend the expiration date to December 24, 2024.)

PRODUCT INFORMATION

ROMEO is a Systemic Resistance Inducer (SRI) that acts preventively. Its active ingredient strongly induces plant defense mechanisms, and so prepares the plant to defend itself against fungal and bacterial attacks.

APPLICATION INSTRUCTIONS

- Apply ROMEO as a foliar spray using conventional spray equipment.
- The recommended range of spray solution is 20-100 gallons per acre.
- Apply to the point of saturation, using a sufficient volume of spray solution to ensure complete coverage of plant foliage without run-off.
- When possible, apply the product on both the top and underside of the leaves.
- Apply at a spray interval of 7-10 days depending on disease pressure.

HOPS	Downy Mildew, Powdery Mildew	0.45-0.68 lbs./acre

RESTRICTIONS AND PRECAUTIONS

- If possible, apply the product early in the morning; avoid application during periods of hot temperatures.
- For use under this SLN, do not apply through any type of chemigation.
- If heavy rain occurs within 48 hours after treatment, repeat the application.
- In the case of high disease pressure/risk, ROMEO should be used in a program with other fungicides.
- Pre-harvest interval (PHI) = 0 days.
