This letter acknowledges receipt of the above Special Local Need (SLN) registration pursuant to Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. This SLN registration permits use of Dimethyl ammonium and Alkyl dimethyl benzil ammonium chlorides on harvest and hedging equipment to control olive knots. Maquat 615 HD can be used as sanitation treatment of equipment used in olive groves to prevent the spread of the bacteria disease olive knot. This is a non-food use with no application to the plant or harvested commodity.



Direction for Use

For prevention of olive knot disease through treatment of equipment. Effective against *Pseudomonas savastanoi* (Olive Knot) at 2000 ppm active quaternary ammonium. Treat all equipment thoroughly at a dilution ratio of 1:108 (2000 ppm active quat). To achieve 2000 ppm, use 1 gallon of product per 108 gallons of water. Treatment can be applied to field harvesting and pruning equipment that come in contact with healthy and diseased plant tissue (saw blades and boom, splines, beater bars, shakers). To prevent the spread of Olive Knot by this artificial means of dissemination, treatments are made by a manual or automated coarse spray, using a dilution rate of 2000 ppm active quat. Do not breathe spray. Surfaces must remain wet for 90 seconds. Allow to air dry. Handlers handling this product must wear goggles or face shield, rubber gloves and protective clothing. Remove contaminated clothing and wash clothing before reuse.

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment wash waters.
