DIRECTIONS FOR USE

Commercial Shrimp Ponds: For control of Ghost shrimp and Mud shrimp in commercial ponds, apply at rates not to exceed 2 gallons of Carbaryl 4L per acre (8 pounds active ingredient per acre). Apply dosage to incoming water as empty ponds are filled to 1-foot depth at 2 gallons Carbaryl 4L per 320,000 gallons of pond water (approximately 3 ppm). Pond and levee edges can be sprayed at similar concentrations.

RESTRICTIONS

Treatment must only be made after crop shrimp have been removed. Treated water should be held for 2 weeks to allow for carbaryl degradation and the pond drained and dried before restocking. Do not apply more than 2 gallons of this product per acre per season.
