This SLN registration permits use of Enlist One (2, 4-D, choline-salt) in/on cotton grown for seed, corn and cotton field crops to control glyphosate-resistant emerged annual and perennial weeds containing Enlist traits in the following counties in Texas: Cameron, Hidalgo, San Patricio, Nueces, and Willacy. This SLN has an expiration date of December 31, 2028.

Enlist One[™] herbicide is a systemic herbicide that is intended for control of emerged annual and perennial weeds. Enlist One is designed to be applied to cotton grown for seed, corn, and cotton field crops containing Enlist[™] traits.

Enlist One may be used according to the package label affixed to the container in the following counties in Texas: Cameron, Hidalgo, San Patricio, Nueces, and Willacy.

Use Restrictions: Do not use Enlist One in Bell, Hill, McLennan, or Williamson Counties.

Precaution: Non-Enlist Cotton and melons are highly sensitive to this product. Applicators must use great caution to ensure drift does not occur downwind to either of these crops.

THREATENED AND ENDANGERED SPECIES
