**It is a violation of Federal law to use this product in a manner inconsistent with its labeling.**

This Section 24(c) label and the Section 3 package label for ZP<sup>®</sup> Rodent Oat Bait AG (EPA Reg. No. 12455-102) must be in the user's possession at the time of application. The user must follow all applicable directions, restrictions, and precautions on the package label and on this SLN label.

#### Use Restrictions:

To control Richardson's ground squirrels (*Spermophilus richardsonii*) in alfalfa, wheat, and barley. All applications must occur shortly after a cutting of the hay and/or prior to the next growth's attaining a length of 2 inches. Alfalfa forage from treated areas must not be harvested until it reaches maturity.

Do not apply this product in a way that will contact workers or other persons, either directly or through Drift. Only protected handlers may be in the area during application. Keep all other persons out of the treated area during this application.

#### Application Directions:

##### Pre-Baiting

When bait is to be used to control Richardson's ground squirrels, pre-baiting with untreated steamed crimped oats at a rate of 6 lbs. per acre 2-3 days before ZP<sup>®</sup> Rodent Oat Bait AG is applied is likely to enhance acceptance of the toxic bait.

**Broadcast Baiting**

This product may be broadcast by dispensing devices that utilize air vacuum, pressurized air, or ground-drive. Apply at a rate of up to 10 lbs. (0.2 lbs. active ingredient) per acre. Make only one application per year. A maximum of 20 lbs. (0.4 lb. active ingredient) per acre may be applied per year. Do not apply by air when wind velocity exceeds 10 mph. Do not apply in piles or permit piles to be formed by application equipment.
