This memorandum serves to provide additional information on the use pattern of methomyl not captured in the LUIS process. RD and PRD's role in the verification process are to fill information gaps and provide division appropriate expertise as outlined in the LUIS Verification SOP for RD and PRD.

PRD provides information and status regarding changes to the chemical use (such as application parameters, cancellations, or label language) that occurred as a result of the reregistration process. RD provides information regarding changes to the chemical use that may have occurred after the date of the LUIS label extraction. In the case a "Data Doer Only" report was

conducted, the CRM and PM will ensure that all highest application rates are reflected on the EFED Spreadsheet. The CRM and PM have drafted the "Registration and Reregistration Verification" section of this memo to clarify knowledge gaps a risk assessor may encounter while using the data contained in the LUIS report.

1. A complete list of the current registrations.

There are a total of 30 products containing methomyl. This includes three technical products (352-366, 70552-2, and 81598-9) and one manufacturing use product (352-361). These four products are used only to formulate methomyl end use products and are not reviewed further. Of the 30 products 18 are SLNs; however, there are only seven SLN registrations for use in California. The other 11 SLNs are not reviewed further.

Table 1 provides a complete listing of the remaining eight section 3 end-use products and the seven SLNs. The table includes the formulation, EPA registration number, date of stamped label, % active ingredient, methods of application, and any relevant use restrictions.

Table 2 provides detailed information for each use site on the remaining end-use labels as well as the pertinent SLNs.

2. Confirm that all mitigation from the 1998 RED is on the labels.

All mitigation measures identified in the 1998 RED are on the labels.

3. Timeline for implementation of mitigation measures outlines in the RED that have not yet been implemented.

All mitigation measures identified in the 1998 RED are on the labels.

4. Verify maximum application rates.

All maximum application rates for each use site are noted in Table 2.

For alfalfa, the labeled seasonal maximum is 3.6 lb ai/A/crop-season per year. Although a cutting may be seen as a crop, it does not change the seasonal maximum use of 12 pints per acre which is equivalent to 3.6 lb ai/A/crop-season per year.

5. Verify that removed uses actually are removed or canceled.

The uses for grapes and strawberry have been deleted.
