This memorandum summarizes the most recent regulatory actions concerning methidathion (PC 100301) as a pesticide active ingredient, and the resulting effects determination relative to the Bay Checkerspot Butterfly (Euphydryas editha bayensis) (BCB), Valley Elderberry Longhorn Beetle (Desmocerus californicus dimorphus) (VELB), California Tiger Salamander (Ambystoma californiense) [Central California, Santa Barbara County, and Sonoma County Distinct Population Segments (CTS-CC, CTS-SB, CTS-SC)], California Clapper Rail (Rallus longirostris obsoletus) (CCR), California Freshwater Shrimp (Syncaris pacificus) (CFWS), San Francisco Garter Snake (Thamnophis sirtalis tetrataenia) (SFGS), Delta Smelt (Hypomesus transpacificus) (DS), and Tidewater Goby (Eucyclogobius newberryi) (TG), and their Designated Critical Habitats. Attached is the Methidathion Product Cancellation Order from 75 FR 30824 (FRL-8828-4), effective as of December 30, 2012, which cancelled the last methidathion products registered for use in the United States.

Pursuant to 40 CFR §155.50, the U.S. Environmental Protection Agency (EPA) formally initiated registration review for methidathion. The docket (EPA-HQ-OPP-2008-0723) opened on March 18, 2009, which described the EPA's preliminary work plan for reviewing methidathion

to determine whether it continues to meet the FIFRA standard for registration. On April 7, 2010, a Notice of Receipt of requests to voluntarily cancel all pesticide registrations containing methidathion was published in the *Federal Register* (75 FR 17735) (FRL-8819-1). No comments were received during the 30-day comment period. On June 2, 2010, EPA published the Product Cancellation Order for all pesticide registrations containing methidathion in the *Federal Register* (75 FR 30824) (FRL-8828-4). The provisions for disposition of existing stocks, subject to the Product Cancellation order, are as follows:

- After December 31, 2012, registrants are prohibited from selling or distributing existing stocks of products containing methidathion labeled for all uses.
- After December 31, 2014, persons other than registrants are prohibited from selling or distributing existing stocks of products containing methidathion labeled for all uses. Existing stocks of products containing methidathion labeled for all uses, already in the hands of users, can be used legally until they are exhausted, provided that the use complies with the EPA-approved label and labeling of the affected product.

EPA published the methidathion Registration Review Proposed Final Decision Notice of Availability in the *Federal Register* (75 FR 44253) on July 28, 2010, for a 60-day public comment period. The public comment period closed on September 27, 2010; one comment was received, but did not change the proposed registration review final decision for methidathion. The final registration review decision for methidathion was completed on September 29, 2010, on the basis that the June 2, 2010 Product Cancellation order cancelled the last remaining products, and concluded the registration review for methidathion.

The Endangered Species Act requires that EPA assess uses of currently registered pesticides relative to any potentially affected listed species. EPA concludes No Effect (NE) for all of the listed species (and no modification to their designated critical habitat) because the June 2, 2010 Product Cancellation Order for all pesticide registrations containing methidathion and the deadlines for the provisions for disposition of the existing stocks, sales and distribution included in the cancellation order ensure that methidathion sale, distribution of existing stocks by registrants would cease by December 31, 2012. Furthermore, the prohibition of the continued distribution or selling of products containing methidathion after December 31, 2014, would ensure that its use will continue to decline, as stocks are exhausted, and will entirely cease in the United States once the stocks are exhausted.

This NE determination has been made with respect to the potential direct and indirect effects to the federally threatened BCB, VELB, CTS-CC, and DS, and the federally endangered CTS-SC, CTS-SB, CCR, CFWS, SFGS, and TG. Similarly, a NE determination has been made for the designated critical habitats for these species (*i.e.*, BCB, VELB, CTS-CC, CTS-SB, DS, and TG). These effects determinations address potential risk to the San Francisco Bay species for which methidathion was alleged to be of concern in a complaint made by the Center for Biological Diversity against the United States Environmental Protection Agency (EPA) on May 30, 2007 (Case No: 07-2794-JCS).

Please let me know if you have any questions regarding this assessment and effects determination for methidathion relative to the BCB, VELB, CTS-CC, DS, CTS-SC, CTS-SB, CCR, CFWS, SFGS, and TG and potential modification to designated critical habitat(s) or as it relates to all other federally listed threatened or endangered species and designated critical habitat.

Methidathion; Cancellation Order for Pesticide Registrations

AGENCY: Environmental Protection

Agency (EPA). ACTION: Notice.

SUMMARY: This notice announces EPA's order for the cancellations, voluntarily requested by the registrants and accepted by the Agency, of products containing methidathion, pursuant to section 6(f)(1) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended. This cancellation order follows a April 7, 2010, Federal Register notice of receipt of requests from the registrants listed in Unit II., Table 2, of this notice, to voluntarily cancel these product registrations. These are the last products containing this pesticide registered for use in the United States. In the April 7, 2010 notice, EPA indicated that it would issue an order implementing the cancellations, unless the Agency received substantive comments within the 30 day comment period that would merit its further review of these requests, or unless the registrants withdrew their requests. The Agency did not receive any comments on the notice. Further, the registrants did not withdraw their requests. Accordingly, EPA hereby issues in this notice, a

cancellation order granting the requested cancellations. Any distribution, sale, or use of the products subject to this cancellation order is permitted only in accordance with the terms of this order, including any existing stock provisions.

DATES: The cancellations are effective December 30, 2012.

III. Summary of Public Comments Received and Agency Response to Comments

During the public comment period provided, EPA received no comments in response to the April 7, 2010 Federal Register notice (75 FR 17735; FRL—8819—1) announcing the Agency's receipt of the requests for voluntary cancellations of products listed in Unit II., Table 1.

IV. Cancellation Order

Pursuant to FIFRA section 6(f), EPA hereby approves the requested cancellations of methidathion registrations identified in Unit II., Table 1. Accordingly, the Agency hereby orders that the product registrations identified in Unit II., Table 1 are canceled. The effective date of the cancellations that are the subject of this notice is December 30, 2012. Any distribution, sale, or use of existing stocks of the products identified in Unit II., Table 1, in a manner inconsistent with any of the provisions for disposition of existing stocks set forth in Unit VI. of this notice will be a violation of FIFRA.

V. What is the Agency's Authority for Taking this Action?

Section 6(f)(1) of FIFRA provides that a registrant of a pesticide product may, at any time, request that any of its pesticide registrations be canceled or amended to terminate one or more uses. FIFRA further provides that, before acting on the request, EPA must publish a notice of receipt of the request in the Federal Register. Thereafter, following the public comment period, the EPA Administrator may approve such a request. The notice of receipt for this action was published for comment on April 7, 2010. The comment period closed on May 7, 2010.

VI. Provisions for Disposition of Existing Stocks

Existing stocks are those stocks of registered pesticide products which are currently in the United States and were packaged, labeled, and released for shipment prior to the effective date of the action. The existing stock provisions for the products subject to this order are as follows:

After December 31, 2012, registrants are prohibited from selling or distributing existing stocks of products containing methidathion labeled for all uses.

After December 31, 2014, persons other than registrants are prohibited from selling or distributing existing stocks of products containing methidathion labeled for all uses.

After December 31, 2014, existing stocks of products containing methidathion labeled for all uses, already in the hands of users can be used legally until they are exhausted, provided that the use complies with the EPA approved label and labeling of the affected product.

Draft Toxicological Review of Formaldehyde in Support of Summary Information on the Integrated Risk Information System (IRIS)

AGENCY: Environmental Protection Agency (EPA).

ACTION: Notice of public comment period and listening session.

SUMMARY: EPA is announcing a 90-day public comment period and a public listening session for the external review draft human health assessment titled, "Toxicological Review of Formaldehyde Inhalation Assessment: In Support of Summary Information on the Integrated Risk Information System (IRIS)" (EPA/ 635/R-10/002C). The draft assessment was prepared by the National Center for Environmental Assessment (NCEA) within the EPA Office of Research and Development (ORD). EPA is releasing this draft assessment solely for the purpose of pre-dissemination peer review under applicable information quality guidelines. This draft assessment has not been formally disseminated by EPA. It does not represent and should not be construed to represent any Agency policy or determination. A committee of the National Research Council, acting under the auspices of National Academy of Sciences (NAS), will conduct an independent scientific peer review of the EPA draft human health assessment of formaldehyde. The peer review committee will hold meetings, some of which may involve public sessions. Public sessions will be announced before each meeting on the National Academies Web site (http:// www8.nationalacademies.org/cp/ projectview.aspx?key=49207). The public comment period and NAS scientific peer review are separate processes that provide opportunities for all interested parties to comment on the assessment. Due to the timing of the NAS peer review meetings, one or more NAS meetings may take place before the close of EPA's public comment period (see DATES below). For NAS meetings that occur during the public comment period, EPA will provide all public
