

**22.5(455B) Special requirements for nonattainment areas.**

As applicable, the owner or operator of a stationary source shall comply with the requirements for the nonattainment major NSR program as set forth in rule 567-31.20(455B). An owner or operator required to apply for a construction permit under this rule shall submit all required fees as required in 567-Chapter 30.
