

10 CSR 10-5.250 Time Schedule for Compliance

(1) General Provisions.

(A) Except as otherwise specified, compliance with the provisions of this regulation shall be according to the following time schedule:

1. All new installations shall comply as of going into operation;

2. All existing installations not in compliance as of the effective date shall be in compliance within six (6) months of the effective date unless the owner or person responsible for the operation of the installation shall have submitted to the Executive Secretary in a form and manner satisfactory to him, a program and schedule for achieving compliance, such program and schedule to contain a date on or before which full compliance will be attained, and such other information as the Executive Secretary may require. If approved by the Executive Secretary, such date will be the date on which the person shall comply.

A. The Executive Secretary may require persons submitting such program to submit subsequent periodic reports on progress in achieving compliance.

3. All other dates notwithstanding, all existing installations in Franklin County shall be in compliance with this regulation by January 31, 1972, except for—

A. cities having a population in the range between two thousand (2,000) and ten thousand (10,000) inhabitants shall be in compliance with 10 CSR 10-5.070 by Sept. 20, 1972;

B. cities having a population of less than two thousand (2,000) inhabitants shall be in compliance with 10 CSR 10-5.070 by Sept. 20, 1973; and

C. sources emitting sulfur dioxide from the use of fuel shall be in compliance with 10 CSR 10-5.110 by January 31, 1973.
