

## DIRECTIONS



### FROM SAN FRANCISCO OR SAN JOSE

Asilomar is located approximately 120 miles south of downtown San Francisco, 105 miles from San Francisco International Airport, and 75 miles from San Jose International Airport.

Take 101 South to 156 West (Exit 336). Continue on 156 West to Highway 1 South to Pebble Beach / Pacific Grove exit (Exit 399A). Turn right onto Holman Hwy / 68 West and continue for 3.1 miles. Turn left onto Sunset Drive/ 68 West and continue for 0.9 miles. Turn right onto Asilomar Ave. The entrance to Asilomar Conference Grounds is 0.2 miles on your left. The Forum will be held in the Kiln Room.
