Dear Ms. Jordan:

In accordance with your letter of March 23, please find attached our Certification Form, properly executed, to withdraw our old EPA Identification Number.

For your information, the old EPA number MAD046128559 covered two groups of buildings on Main Street--all referred to as One Main Street. We consolidated our operations at one of the groups, recently assigned the street number of 355 Main St. by the postal authorities.

White Consolidated Industries sold that group of buildings now referred to as One Main Street to Sidney Covich as of 10-23-84.

White Consolidated Industries sold that group of buildings now referred to as 355 Main Street to ATF-Davidson Company, Inc. as of 12-9-86.

ATF-Davidson Company, Inc. now has nothing to do with One Main Street. We have obtained a temporary identification number and have sent in a copy of our Notification Form to Tanya Sweeney as you suggested, requesting a permanent EPA Identification Number, for our newly designated location.

I hereby request a change to withdraw the EPA ID Number.


