Good morning Jane,

This email is a follow up to our SSA conversation last week regarding the type of ammunition currently utilized at Camp Edwards and proposed for the MPMG Range. I have attached 2 graphics. The first is taken from the Final Environmental Assessment for the MPMG August 2020. This identifies the types of weapons and ammunition proposed by the Mass Guard for the MPMG Range. The first two lines of this graphic identify 5.56x45 mm ball and 7.62x51 mm ball ammunition for the rifle/automatic weapons proposed for use.

The second graphic identifies the current ammunition utilized at Camp Edwards firing ranges within the Upper Cape Water Supply Reserve. The first column has the Department of Defense Identification Code (DODIC) which identifies the type of ammunition and how it is packaged for shipment. Based on my research and discussion with Camp Edwards, the 5.56mm ball M855A1 ammunition is the copper Environmental Performance Round (EPR), the exact same ammunition for DODIC AB56, 57,58,73 and 77. The different DODICs identify the packaging for ammunition shipment and identify if the ammunition is linked together in a belt for use in a specific weapon system. DODIC AB73 includes the M856A1 tracer linked 4 rounds:1 tracer.

Similarly, DODIC AB79,81,86 represent the same 7.62mm ball M80A1 copper EPR. DODIC AB86 includes the M62A1 tracer linked 4 rounds:1 tracer.
