I submitted FOIA request no. EPA-2020-004152 today online. (I see that the request number does not have "R1" in it, but it is directed at Region 1.)

For your convenience, I am also emailing you the request here. There are two attachments that I am sending in separate emails due to file size. The request is:

We request a complete copy of NPDES Permit No. NH0001465 issued by EPA Region 1 for Merrimack Power Station in Bow, NH. EPA's online Administrative Record includes AR-236 (see attached), which is 23 pages and includes Part I and Attachment I of the Permit. The plant's current owners provided us with the attached 58-page document, which also includes Part II, several pages of the permit that purport to have been modified in October 1992, and several cover letters. It also has handwritten markings and highlights. We would like to obtain a copy of EPA's complete version of the permit. Thank you.

We understand that EPA's office in Boston is closed and that this may delay processing.
