As you requested during the conference call with representatives of Granite Shore Power and PSNH on December 1st, I have attached in draft a template of an Assignment and Assumption Agreement between PSNH and GSP Merrimack LLC relative to the NPDES permit for the Merrimack Station facility. The wording of this agreement would be replicated in separate agreements particular to both the Newington Station and Schiller Station facilities.

On a related matter, thank you for forwarding the draft Permit Modification for Transfer of Ownership documents for the Merrimack, Schiller and Newington Stations.
