Hi Mark –

This is just a brief update on the status of the transaction involving the sale of PSNH's thermal assets to Granite Shore Power. I had previously indicated that the parties were shooting for a December 29, 2017 closing. Given the complexity of separating the generation assets from the transmission and distribution assets, as well as a number of other factors, the transaction were not able to close on that date. However, the parties currently are working towards a proposed closing date of January 12, 2018. Again, this is not yet a set-in-stone date. I will continue to stay in touch and will let you know when we have a firm closing date.
