This minor permit modification is issued in accordance with Section 22a-430 of Chapter 446k, Connecticut General Statutes ("CGS"), Section 22a-430-4(p)(5) of the Regulations of Connecticut State Agencies ("RCSA") adopted thereunder, as amended, and Section 402(b) of the Clean Water Act, as amended 33 USC 1251, *et. seq.*, and pursuant to an approval dated September 26, 1973, by the Administrator of the United States Environmental Protection Agency for the State of Connecticut to administer a NPDES permit program.

**DOMINION NUCLEAR CONNECTICUT, INC.** ("Permittee") shall comply with all conditions of Permit No. CT0003263 issued on September 1, 2010 with the following modification:

Discharge Serial Number ("DSN") 026 is removed from NPDES Permit CT0003263. The discharge associated with DSN 026 consists of "Parking area and/or roadway stormwater runoff" only. NPDES Permit CT0003263 requires no monitoring for DSN 026. This type of discharge does not require coverage under the NPDES permit and is therefore being removed from Table FF of NPDES Permit CT0003263 consistent with 40 CFR 122.63(e)(2) and RCSA 22a-430-4(p)(5)(B)(v).

The Commissioner reserves the right to make appropriate revisions to the permit in order to establish any appropriate effluent limitations, schedules of compliance, or other provisions that may be authorized under the Clean Water Act or the Connecticut General Statutes or regulations adopted thereunder, as amended. The permit as modified under this paragraph may also contain any other requirements of the Clean Water Act or Connecticut General Statutes or regulations adopted there applicable.

All other terms and conditions of Permit No. CT0003263 issued on September 1, 2010 shall continue in full force and effect.

This minor modification is hereby issued on Sept. 24, 2013.
