In accordance with the Rhode Island Pollutant Discharge Elimination System (RIPDES) Regulations promulgated under Chapter 46-12 of the Rhode Island General Laws of 1956, as amended, the Rhode Island Department of Environmental Management (DEM) hereby acknowledges termination of the above-referenced RIPDES Permit.

The permit, which became effective on October 1, 2011, and expired on September 30, 2016, pertained to Coastal Plastics, Inc (RIPDES Permit No. RI0022080) discharges to Wood River. In accordance with §1.13 of the Regulations for the Rhode Island Pollutant Discharge Elimination System (RI Code of Regulations; 250-RICR-150-10-1.13), the conditions of the expired permit have continued in force since a complete application for renewal of the permit was submitted. Correspondence dated from July 10, 2019 to DEM indicated that the discharges have been eliminated since June 30, 2019. Since the discharges have been eliminated as of June 30, 2019, the above-referenced RIPDES Permit was no longer required for your facility.



PROPOSED TERMINATION OF A RHODE ISLAND POLLUTANT DISCHARGE ELIMINATION
SYSTEM (RIPDES) PERMIT TO DISCHARGE TO WATERS OF THE STATE

TYPE OF FACILITY:

The facility, which has been the source of a wastewater discharge, was issued a permit which became effective on October 1, 2011, and expired on September 30, 2016. This facility was engaged in manufacturing of plastic tubing. The permit pertains to Coastal Plastics, Inc.'s discharge consisting of contact and non-contact cooling water. The discharge point is no longer active since June 30, 2019.

BASIS FOR DEM'S TENTATIVE DECISION TO TERMINATE:

On July 10, 2019, Coastal Plastics, Inc. informed DEM that their facility located at 35 Mechanic St., Hope Valley, RI 02832, has ceased its production operations as of June 30, 2019. The facility was no longer discharging any cooling water into Wood River. Coastal Plastics, Inc. requested that their permit (RIPDES No. RI0022080) be terminated. DEM inspected the facility on August 7, 2019 to verify that the facility has ceased operation, stopped discharging, and sealed the outfall pipe. During the inspection DEM verified that the facility has ceased


operation, stopped discharging, and sealed the outfall pipe, but has not sealed floor drains that connect to the outfall pipe. Coastal Plastics, Inc. sent DEM pictures confirming sealing of floor drains on August 27, 2019.
