Dear Mr. Thomas:

By this letter, the Department of Environmental Protection (Department) is terminating the above referenced license last issued on June 2, 2016, to Thomas Property Management, LLC. The license authorized the discharge of 1,000 gallons per day of treated wastewater to soil above groundwater, Class GW-A, via a sub-surface wastewater disposal system in Hermon.

Based on an email dated December 10, 2019 from you to Clarissa Trasko of the Department (EMRO), it is our understanding you are requesting to terminate said WDL as the Hermon Car Wash facility permanently disconnected from discharging to the leach field and replaced the water treatment system with a closed loop system from Aqua Bio Technologies as of the December 10, 2019 email. The Department will be inactivating the facility in our database so that Discharge Monitoring Reports and billing statements are not sent to you in the future. By copy of this letter, we are notifying the U.S. Environmental Protection Agency of the retirement of the license.

Please be advised that a license may be needed from Department for any future discharge of pollutants from this facility to the surface or ground waters of the State of Maine, either under current ownership or new ownership. Any new permit/license would be based on the characteristics of the effluent being discharged and the impacts of the discharge on the quality of the receiving water.
