Please note that any comments submitted during the initial public notice period of May 3, 2011 through June 1, 2011 and of the extension period of May 19, 2011 through June 18, 2011 are considered to be valid and part of the official record. There is no need to resubmit any comments submitted during the original public notice period or the extended comment period. In reaching a final decision on this draft permit, the Regional Administrator will respond to all significant comments and make the responses available to the public at EPA's Boston office.

FINAL PERMIT DECISION:

Following the close of the comment period, and after the public hearing, the Regional Administrator will issue a final permit decision and forward a copy of the final decision to the applicant and each person who has submitted written comments or requested notice.
