Dear Interested Persons:

On October 31, 2013, the Maine Department of Environmental Protection (Department) issued two new proposed draft General Permits for review and comment. Public comment on the two draft General Permits is allowed until the date of a final agency action on the draft General Permits.

These General Permits are being developed in response to Legislative Resolve Chapter 44, "Resolve, Directing the Department of Environmental Protection To Amend Its Rules Regarding Snow Dumps" (Resolves 2011 ch. 44) which directs the Department to review its rules regarding snow dumps to determine "[h]ow the rules may be amended to expedite the licensing process for municipalities that cannot be exempted from the waste discharge licensing requirement" and to ensure "the rules do not conflict with the Federal Water Pollution Control Act."

In accordance with *Rules Concerning the Processing of Applications and Other Administrative Matters*, 06-096 CMR 2(8) (last amended August 25, 2013), the Department has scheduled a public meeting for the purpose of collecting comments that will become part of the record in this pending action.
