Sharon,

In response to an EPA 308 letter, PSNH submitted a report prepared by Enercon Services in 2008 to provide information and conceptual-level engineering and feasibility analyses on various CWIS technologies and operational measures designed to reduce impingement/entrainment. A few more targeted reports have since been prepared and submitted by both Enercon and Normandeau Associates in response to more direct requests from EPA. Please find attached a follow-up submittal from Enercon that updates and supplements the original report to address a number of changes that have occurred in the last several years, most importantly the latest 316(b) regulations. Also attached is the transmittal letter.

I will provide you with a hard copy of the report next week. Hopefully you find the information useful, we would very much like to meet to discuss the technologies when you have completed your review.
