Dear Mr. Nagle,

We have completed our consultation under section 7 of the Endangered Species Act (ESA) in response to your original November 29, 2017 letter and December 15, 2017 revised letter, regarding the above-referenced proposed project. We reviewed your (the action agency) consultation request document and related materials. Based on our knowledge and your materials, we concur with your conclusion that reinitiation is required but that the proposed action is not likely to adversely affect any ESA-listed species or designated critical habitat under our jurisdiction. Therefore, no further consultation pursuant to section 7 of the ESA is required.

While it does not affect the validity of your conclusions, we note that you seem to have misinterpreted the definition of physical feature two of the Atlantic sturgeon critical habitat designation. Feature two includes all aquatic habitat within the salinity gradient between 0.5 up to as high as 30 parts per thousand (ppt) between the river mouth and spawning sites that also contains soft substrate. You state that because salinity fluctuates between 15 and 33 ppt, that the action area does not contain feature two. While we agree that the lack of soft substrate in the action area would mean that feature two is not present, the salinity of the action area is consistent with the description of feature two.

Reintiation of consultation is required and shall be requested by the Federal agency or by the Service, where discretionary Federal involvement or control over the action has been retained or is authorized by law and: (a) If new information reveals effects of the action that may affect listed species or critical habitat in a manner or to an extent not previously considered in the consultation; (b) If the identified action is subsequently modified in a manner that causes an effect to the listed species or critical habitat that was not considered in this consultation or; (c) If a new species is listed or critical habitat designated that may be affected by the identified action.
