PUBLIC HEARING:

EPA conducted a public notice period from November 2, 2005 – December 1, 2005 concerning NOIs submitted by these and other MS4 Operators. EPA received comments and requests for public hearings from several persons. Based on the significance of public interest, EPA has determined that a public hearing shall be conducted to receive additional comment concerning NOIs submitted by the Massachusetts Highway Department and the Massachusetts Turnpike Authority. Accordingly, a public hearing will be held as follows:

The following is a summary of procedures that shall be followed at the public hearing:

- a. the Presiding Officer shall have the authority to open and conclude the hearing and to maintain order;
- b. any person appearing at the hearing may submit oral or written statements and data concerning the Notices of Intent; and
- c. the Presiding Officer may close the hearing prior to 11:15 AM if all those persons wishing to provide statements and data have previously done so.

Any person wishing to provide comments concerning these NOIs may do so in oral or written form at the public hearing. Comments will also be accepted by mail or email,
