

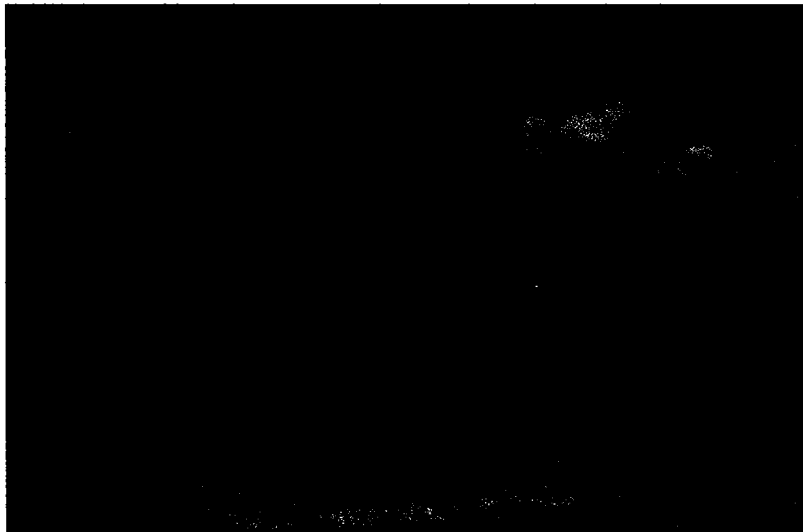
**E. Certification**
