**Subject: Annual Update - NPDES Phase II General Permit
Town of Sandwich Stormwater Management Plan: Year 4 Update**

Dear U.S. EPA and MaDEP:

As required under the NPDES Stormwater General Permit, the Town of Sandwich hereby submits this annual update of the Town's the Stormwater Management Plan.

Year 4 Update

The Town of Sandwich continues to be very proactive in the field of stormwater management and has successfully fulfilled many of its goals established in its Stormwater Management Plan.

This Annual Update provides a look at major accomplishments, new programs and goals and the status of goals that have not been met as scheduled. Below is a summary of Year 4 implementation.

Major Fourth Year Accomplishments (Spring 2006 - Winter 2007)

Below is a list of some of the significant goals accomplished over the past year:

Drainage System Identification & Mapping

GIS Drainage maps were completed this past year. These maps provide details such as location and type of drainage facilities (including outfalls), pipe connections, and drainage easements. This information is being used by the DPW to respond to resident requests, record drainage maintenance and upgrades and as a planning tool for future drainage projects. GIS Drainage maps are shown in the Appendix.

One valuable feature of the drainage mapping system is the service request function. This function allows residents to identify drainage problems on a GIS map using the

Town web site. The information is then e-mailed to the DPW, which promptly inspects the problem and makes necessary repairs. This function is shown in the Appendix.

Stormwater Inspections and Monitoring

The Town has continued to develop a program to effectively inspect and enforce stormwater issues. Some of the highlights of this program are listed below and shown in the Appendix:

- Developed reporting and inspection procedures for illicit detection. For example, when possible illegal discharges (e.g., sump pumps) are identified, the Health Agent is notified, who promptly inspects the source of the problem and enforces mitigation if necessary. The DPW maintains a record of all identified sites reported to the Health Inspector.
- Developed reporting and inspection procedures for erosion control problems. For example, when erosion control issues are identified (e.g., new home construction without hay bales), the Building Inspector is notified and a visit and letter promptly follow warning the owner of the violation and consequences. Due to the Building Departments heavy workload, the Town's enforcement policy is being revised to allow the DPW to assist in the inspection and enforcement of such violations. The DPW maintains a record of all identified sites with erosion control problems.
- Reporting of all stormwater and drainage problems. As discussed earlier, the public is able to send drainage service requests to the DPW via the GIS web site. The DPW also records all drainage issues, whether identified by the public or town officials. This is particularly helpful during severe rain events due to the backlog of calls. Records of drainage issues are shown in the Appendix. Future drainage requests will be recorded on the GIS drainage database.

Stormwater Seminars

Town staff continues to attend stormwater seminars to obtain knowledge of new Best Management Practices (BMP's) technologies and to learn of successes achieved by other municipalities related to stormwater management. Staff attended a seminar at the UNH Stormwater Center, which has a unique field facility to evaluate and verify the performance of stormwater management devices and technologies. Staff has also participated in the EPA's Stormwater Program Webcast Series. The Town will continue to send staff to these seminars and others related to stormwater impacts and management. Information obtained from these seminars and research facilities will be implemented into the Town's Stormwater Management Plan.

New Programs/Goals

Below is a list of new accomplishments/goals that have been added to the Town's SMP (i.e., goals not on the original General Permit NOI):

- The Town of Sandwich's Stormwater Management Plan and Best Management Practices were featured in an article in the nationally published "Municipal Sewer &

Water” February 2007 edition. The article highlighted the efforts taken by the Town to minimize impacts from stormwater runoff. (See attached article).

- The Town of Sandwich participates in a Household Hazardous Product Collection Day four times per year. As part of this effort, the Town educated the public and encouraged the public to recycle more. This effort, called the “Use Less, Recycle More” campaign, included education about rain barrels and also gave away a free barrel to coincide with the Earth Day celebration. The Town will continue to educate the public about stormwater impacts and will encourage residents to use rain barrels to recycle their stormwater. (See attached information).

- The Project Storm Team, a Cape-wide stormwater management focus group, and the Cape Cod Commission teamed up to apply for a grant to develop BMP’s for Cape Cod. The proposal, titled “Developing an Alternative Stormwater Management Design Manual for Cape Cod, Massachusetts” will allow towns to implement stormwater BMP’s appropriate for the Cape’s environment.

Status of Goals for Year 4


Similar to the original table submitted for the NPDES General Permit, the attached table shows goals proposed for all Six Control Measures. This updated table reflects new goals and the status of Year 1, 2, 3 and 4 goals. The yellow highlighted blocks represent goals scheduled in each season of respective years. Words highlighted in red represent goals that have not yet been reached. New goals mentioned earlier have also been included in the table.

The attached appendices show several of the actions performed by the Town to meet the Year 4 goals listed in the table.

Conclusion

The Town of Sandwich’s accomplishments over the past four years meet or exceed most of the scheduled goals. Also, new goals have been created to further enhance the Towns Stormwater Management Plan.
