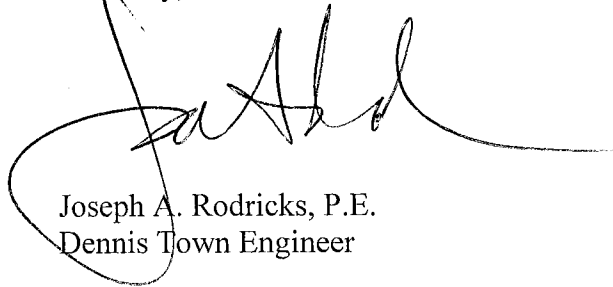

Part II. Self-Assessment

The Town of Dennis has completed the required self-assessment and has determined that our municipality is not currently in compliance with the 5 year permit period, a committee worked on a comprehensive stormwater management. The Town is placing an article on the October Special Town Meeting for approval of a proposed Stormwater Management Control By-law. This by-law, which will provide the Town with a comprehensive town-wide stormwater management plan, has been in development for 5 years. Originally scheduled for acceptance in 2008, negative public comments required the Board of Selectmen to refer the matter to a committee for further revisions.

7b. WLA Assessment

For several years the Town has identified the Bass River and Kelley's Bay area as the highest priority for immediate implementation of BMPs. The Town is currently attempting to add mitigation measures into the design of park improvements at the newly acquired Bass River Park in order to mitigate flows into Bass River. The Town has also identified the Pound Pond watercourse in the vicinity of Lower County Road as another priority in developing BMPs. Design of a BMP on Lower County Road was included in plans for Seaview Park and construction was scheduled for 2009. Annual Town Meeting is also scheduled to approve an article funding a study of the Division Street drainage system which outfalls into this pond for the purpose of identifying potential sources of pollution and developing mitigation measures.

Part IV. Summary of Information Collected and Analyzed

A total of 23 Town beaches were tested on a weekly basis during the months of June, July and August 2008 and resulted in 11 (12 days) beach closures.
