Planning for the 2012 Greenscapes program is underway, and we look forward to Boxford's continued participation. Since its inception in 2007, the Greenscapes North Shore Program has been successful in helping communities like Boxford meet the public education and outreach requirements under the NPDES Phase II Stormwater program as well as their water conservation measures required under the Massachusetts Water Management Act.

We would like to meet with you in the near future to show you what we have developed for the Outreach and Education component of Boxford's upcoming NPDES MS4 Phase II Stormwater permit Notice of Intent (NOI). This permit, which was supposed to have been issued by EPA in 2011, continues to be delayed. However, we remain fully committed to the project and once the permit is issued we will complete the NOI outreach and education section in the permit.

Regarding the 2012 Greenscapes Program, we have learned that most of our North Shore communities feel strongly that educating homeowners continues to be a priority. Since the new permit will not go into effect until next year, we have the opportunity to continue this very important work.

This year's educational materials include an updated full color "Guide to Greenscaping." This multi-page guide provides comprehensive and detailed information about environmentally-friendly gardening and lawn care practices that protect and conserve water supplies. Articles address how to grow a healthy and attractive lawn that uses less water; alternatives to fertilizers and pesticides; how to make and use compost; how to create a rain garden; suggestions for drought tolerant plants; and more.

We will also provide Boxford with newspaper articles on Greenscaping practices for local papers, access to a free workshop on organic lawn care, the Greenscapes website, and seasonal monthly Greenscapes e-newsletters.

Program Outreach Deliverables for 2012:

- **Updated full color "Guide to Greenscaping"**
This multi-page guide provides comprehensive and detailed information about environmentally-friendly gardening and lawn care practices that protect and conserve water supplies. Articles address how to grow a healthy and attractive lawn that uses less water; alternatives to fertilizers and pesticides; how to make and use compost; how to create a rain garden; suggestions for drought tolerant plants; and more. Quantity: 500, more available for additional \$50 per hundred guides
- **Newspaper articles**
Greenscapes will provide three articles on various water conservation, stormwater, and green lawn care topics for your local papers.
- **Homeowner's Workshops on Greenscapes Practices**
 - A free full day workshop on Saturday, March 31: 9am – 3pm at the Parker River National Wildlife Refuge Headquarters in Newbury about organic land care practices and what landowners can do in their own backyards to protect local watersheds. Topics include lawn care, landscaping with native plants, healthy soils, and low impact development methods for reducing stormwater runoff.

As a participating community, the North Shore Greenscapes Coalition will make a presentation to the residents of Boxford at the time and venue of your choice.
