The funding was used to upgrade Monson's drainage in areas prone to flooding. Work included design and construction of new drainage in the Rogers Field area and design for new drainage in the Park Road area. This grant also included a budget for tree planting to offset the deforestation caused by the severe weather in 2011 and to retain and slow runoff. This work was largely finalized during this reporting year.</p> <p>During this reporting period, the Town secured a \$120,000 grant through the United States Department of Housing and Urban Development to complete the construction of the Park Road area drainage upgrades, which were originally designed under the EOE A grant. The grant will fund replacement of the existing infrastructure. The existing drainage has been scoured by heavy runoff events, causing damage to the nearby roadway. The project will be put to bid upon the completion of the environmental review process.</p> <p>Additionally, the Coalition has created a stormwater BMP "toolbox"—a database that summarizes practical types of BMP's and presents design factors, technical data, and construction limitations.
