Part II. Self-Assessment

The Town of Framingham has completed the required self-assessment for Permit Year Twelve and finds that our municipality is in compliance in general with the permit conditions.

For compliance with the six Minimum Control Measures, the Town completed the following for Year 12:

- The Town undertook several education and participation efforts, including:
 - o Hosted annual Household Hazardous Waste Collection Day and Rain Barrel Event for residents
 - o Participated at the Town's Earth Day (April 26, 2014) and Riverfest (June 20-22, 2014) celebrations.
 - Provided water resources classes at Potter Elementary School, McAuliffe Charter School, and Framingham State University.
 - o Conducted a storm drain marking event on September 13, 2014 with Boston Church of Christ volunteers in Downtown Framingham near high-use facilities like Town Hall, the Police Station, the library, and Framingham Union Hospital.
- The Town reviewed and updated our IDDE Implementation Plan. The Town continued water quality monitoring and sampling at approximately 20% of the Town's outfalls. The Town investigated ten potential illicit discharges and addressed four activities that had potential to impact stormwater runoff.
- The Town's Engineering Division reviewed over 150 construction and post-construction submittals for compliance with the Town's bylaws and the MassDEP stormwater management standards.
- The Town's Department of Public Works completed 113 stormwater system related work orders. Water quality BMPs, over 7,200 catch basins, and over 52,000 feet of drainage lines were inspected and cleaned. Street sweeping was conducted on all roads at least once, twice in high priority areas, and almost daily in the downtown area.

The Town continues to develop and update our Stormwater Master Plan using a prioritized sub-basin approach. The Stormwater Master Plan includes field data collection, GIS data compilation, asset condition assessments, hydrologic/hydraulic modeling, water quality assessment, alternative improvements evaluations, and capital improvement recommendations. The Town has completed the plan for 12 out of our 22 sub-basins. The Town continues to plan for and implement the recommendations from the initial phases of the master plan, namely replacement or rehabilitation of structures at high risk with high consequence of failure.

The Massachusetts Natural Resource Damages Assessment and Restoration Program awarded a grant to the Town of Framingham for a stream restoration project to improve natural resources habitat and water quality in Beaver Dam Brook, a tributary in the Upper Sudbury River watershed. The grant funds are part of the General Motors (GM) trust fund connected to the company's former contaminated industrial site in Framingham.
